In Memory of Nelson L. Dawson 1933-2020

Mr. Nelson Dawson, a native son of Amite County went to be with his Lord and Savior on January 29, 2020. Mr. Nelson grew up in the Busy Corner Community, he was a graduate of Oxford High School, and studied at Southwest Mississippi Junior College before joining the Armed Forces. After returning from military service, Nelson served with the Baton Rouge Fire Department as a Fire Prevention Chief. After his retirement in 1988, Nelson returned to Amite County, where he served as Arson Investigator for the Amite County Sheriff Department. Mr. Nelson was the thirteenth (and last) child of his parents, Luther Cleveland Dawson and Tressie Melissa "Allie" Bateman Dawson. Mr. Nelson was a true genealogist. Over the years he published three books on the Bateman and Dawson families. Most of the research for his books was done the old fashioned way: traveling to the Carolinas and Europe, working with phone lists, making court house visits and interviewing people. Mr. Nelson started using Family Tree Maker software at some point shortly after it came on the market. Over the years, Nelson was able to amass a large family tree with over 100,000 names. Mr. Nelson and our good friend, Glen Huff, collaborated on building out the family tree lines for generations. In recent years, Nelson submitted a DNA test, added his tree to Ancestry.com, and continued to keep up with the latest in research technology. Nelson loved his pets and beautiful yard, enjoyed daily visits to the Liberty Courthouse and the Liberty Drug Store for coffee (photo below). Mr. Nelson shared so much with so many over the years, opening up new windows into the past. He had a way of making you feel like you were his best friend! As we learned at his funeral, he had that effect on most everyone that knew him. His was a lifetime of service to his faith, family, nation, community, and friends.



In Memory Oma Earl Jones Gordon 1932-2020

The Amite County Historical and Genealogical Society lost another stalwart member with the passing of as I like to say "Our" Oma Gordon. Oma had the same nature as I do, Do What Needs to Be Done, Ask Questions Later because Once Something is effectively done, little will be done to negate. Oma and her husband, Bill Gordon, put The Society on the sound financial footing that it enjoys today and, yes, I was a co-conspirator in this affair—the Publication of the WPA Public Works Project Books for Amite County, Mississippi. Oma and I had done our homework, the copyright of the Federal Government had long expired which meant the two volumes were just waiting to be published. I had removed the two volume originals from the Little Red School House Collection, loaning them to Oma Gordon for the sole purpose of a creating a clear copy for publication. This project took her

one week of solid work then she and I went to a Publisher in Baker, Louisiana. A quote of \$7,000 to publish was given to us, which was an amount The Society did not have. Oma and Bill Gordon, without second thought, advanced publication in The Society's name by a loan paying all publishing costs. These Volumes initially sold for \$125.00 a set and within two months, the loan was repaid in FULL, these books sold on their own. The first printing quickly Sold Out and a second printing was ordered, they too sold quickly. In the 2nd printing a pagination mistake was made which did not affect the book's content and was only realized toward the end of the book's sale, Oma went back to the publisher who in turn actually published a 3rd printing gratis. Those are the few remaining books on sale now.....

Our Oma liked to sojourn throughout The County taking photographs and learning the history of every old place and cemetery that could be imagined and some that could not be, on many occasions, we rambled together... One of the Highlights that she told me she enjoyed most was "The Invasion" as we came to refer to it. I scheduled a time to see the Antebellum home of Mr. Hosea Carraway on Highway 24, built by builder, if memory holds, Drury Cook in the 1830's. At one time, Mrs. A. E. Cole of Gloster (known in East Fork as Mrs. M. E. Bornman) owned this house. Much of the period furniture within the house came from Mrs. Louise Martin Carraway's Family. Being a private residence of a very private man, the home had never been on tour let alone been photographed. On this day Mrs. Oma changed that and got her photographs, preserving this historic home for posterity.

Cemeteries were also a Delight! One day, Oma, Jeannie Livingston and I embarked on an all-day sojourn on Longleaf Farms. The Cemetery Tour given by David Anderson was the highlight of that day! The remote Cemetery of the 19th Century Preacher Zachariah Reeves was our first destination. While we were there, David Anderson received a phone call from a Cutter (logger) that he had just found another Cemetery. They had turned over several markers and determined it to be a Weathersby Cemetery. We went to this location immediately. This Cemetery is Not Recorded and remains so, a regret that has not been rectified...

Our Oma served as President, Vice President and Board Member at Large, Mr. Bill in the Black Hat always in The Picture with a Helping Hand... Oma loved Her Family, Her Heritage and Her History and Our County of Amite as No Other, She was truly a Daughter of The South.... And as they did in the 19th Century, I will sign off, One that Knew Her, WGB.
