#### CAPTAIN HIRAM MORGAN

Captain Hiram Morgan was born on March 1, 1824, to William Joseph Morgan, Sr. and Elizabeth Gayden, here in Amite County, Mississippi. In William's will dated June 21, 1830, William stated that first, all of his debts be paid. He wanted his estate to remain and kept together on his plantation for the maintenance and education of his children, until his youngest sons William and Hiram each became 14 years of age. At that time he wanted his estate to be equally divided among his wife Elizabeth and all of his children: Phebe, Wiley, James, Fielding, Benjamin, John, Diana, William, and Hiram. He requested that Fielding have the care and management of the plantation and hands until the division took place. Elizabeth was the executrix of the will and his son Wiley was executor.

Hiram was in the Mexican War from 1846 to 1848 as a Private in the 1st Mississippi Infantry, Company B (Wilkinson Guards). His wife Augusta filed for a pension from the Mexican war in 1888. Hiram married Augusta Elna Hamilton on February 8, 1849. The 1850 Census shows Hiram and Augusta living with Elizabeth Morgan and Hiram's older brother John. The 1860 Census shows that Hiram was a planter and that he and Augusta had five children: Susan age 9, Prentiss age 7 (says Printus—male on census), Elizabeth age 4, Hiram age 2, and a 2 month old son. The 1860 slave schedule shows that Hiram owned 4 female adults, 4 male adults, one male teenager, and 6 male children. One account states that he had lost his first born son in infancy and had five surviving children, including a daughter, Augusta Rosina, who was born in 1863 either shortly before or after her father's death. Hiram and Augusta were members of Unity Presbyterian Church and there are records indicating that their daughter Prentiss Adelaide was baptized there.

Hiram appeared on the muster roll as Captain of Company B (Amite Guards) Mississippi War Battalion on April 1, 1862, and on roll as Captain of Company B, 33 Regiment Mississippi Volunteers, which was organized on April 17, 1862, until he was killed near Deer Creek Mississippi in the early phase of the Vicksburg campaign. The story goes that Hiram was returned to Amite County by one of his close friends who stole a military wagon. When his wife Augusta saw the wagon, she ran out of the house and was greeted by the words, "I've brought Hiram home." Hiram was buried at the Morgan -Gordon Cemetery on Hwy 568, just north of Gillsburg, MS.

In the 1870 Census, after the death of Hiram, Augusta is listed as head of household as A. E., with children S. S. (Susan) age 18, P. A. (Prentiss) age 16, E. A. (Elizabeth) age 13, H. S. (Hiram) age 12, G. M. age 10, ?. B. age 8 (male born 1862), and D. W. age 22.
