# History of the McGehee – Beall House

This marvelous Amite County home was built in about 1845 by **William Hansford Crawford McGehee** on land originally owned by his grandfather, Samuel McGehee. Samuel, who was originally from Virginia, received land grants in Mississippi for his service. Samuel came to Amite County from Georgia in about 1805, bringing with him ten of his twelve children, the last two, David and Nancy, were born in Mississippi. Three of Samuel's youngest sons each married a sister from the Downs family. Two of the sons got married in 1819 and the third got married in 1823. Samuel's 11th child, David McGehee (1797-1848) married Mariah Downs. David and Mariah's firstborn son was **William Hansford Crawford McGehee**.

**William H. C. McGehee** (born 1820/22) married **Amanda Ophelia Jones** (1829-1888) on January 5, 1843 and had four children before William died of tuberculosis between November 1859 and January 1860. Their four children were Woodford-Livingston (1848-1926), **Jane "Janie" Ophelia** (1848-1926), Martha Elwood (1850-1947), and Mariah C. "Mollie" (1858-1946). Mr. Joseph S. Reeves became the executor of W. H. C. McGehee's estate, and not long after, married Mr. McGehee's widow. Amanda and Mr. Reeves had a couple of children together. It seems that Mr. Reeves was, according to my Grandmother, "a Dandy", and Amanda was afraid Mr. Reeves might lose some of her property gambling, so she decided to divide up the properties (some with houses and some with no house) between all of her children, including the children she had with Mr. Reeves. All of the children's names were put in a hat, and names were drawn for each piece of property. The name of Jane Ophelia "Janie" McGehee was drawn (by her step-father, as she was a minor) to receive the property. The house came with approximately 160 acres of land, small cottages for "the hands", a log barn, a Dove Coat, Smoke house, out house, and the main house which is located at 5170 Pecan Road, Liberty.

## The Second "Owner"

**Jane Ophelia "Janie" McGehee** was born December 12, 1848, most likely IN the house she would later own. In 1867, at the age of 19, Janie married Thaddeus Ridley Beall. They had five children, Elisha Vivian, Claudius Van "Jack", Martha "Mattie" Amanda, Ethel Estelle "Edyie", and Thomas Thaddeus. Mattie Beall married Isiah Tucker in 1890 in Baton Rouge. They moved to Texas and had two daughters, after which Mr. Tucker passed away in 1893. Mattie returned to Liberty to live with her parents with her two young daughters, Mary Ethel (1891-1958) and Ira Beall (1893-1970), in the McGehee-Beall house, during which time she married Leon Compton McGehee. Mattie and Leon either shared the McGehee house with her parents or lived in the General Store that her parents owned a little less than a mile from the house (approximately located at the current intersection of Pecan Road and Freeman Road.) On November 7, 1914, T. R. Beall and Janie Ophelia McGehee Beall "sold for \$1.00" the house on Pecan Road with 152 acres (more or less) to Mattie McGehee and her husband, Leon Compton "Coon" McGehee "for the love and affection we have for our daughter and the further consideration of their taking care of us during our natural lives."

### **The Third "Owner"**

**Martha "Mattie" Amanda Beall Tucker McGehee and her husband Leon Compton McGehee** took full possession of the McGehee-Beall House upon the death of Mattie's parents, (Janie and Thaddeus Ridley Beall). While living in the McGehee-Beall house, Mattie had six more children with Leon - Lilly Beall (1896-1984), Hattie Helen (1898-1992), Janie Lee (1900-1989), Tommie Alene (died in infancy), Thomas Leon "Tommie" (1905-1988), and Thadius Claude "Nuda" (1902-1918), who died from appendicitis on the way to the hospital in McComb from Liberty in a wagon with his sister singing to him, "I'll take you home again Kathleen". In their old age, Mattie and Leon decided to live apart. Mattie was left to run the "farm" on her own and it apparently overwhelmed her, so she decided to sell the land and house including all the crops, equipment and animals. The house was listed with a realtor in March of 1936 with selling price of \$3,000.

### **The Fourth "Owner"**

On October 12, 1943, **Alney Jones and wife, Janie Lee McGehee Jones** (born in the McGehee-Beall house in Oct 1900) purchased the house and land from Mrs. Jones parents, Mattie A. McGehee and Leon C. McGehee for the sum of \$1,100.00. Alney Jones was a Liberty Native, but employed with Esso in Baton Rouge. They lived in Zachary and had two children, **Robbie Adair Jones Yaun** and **Alney Webster Jones, Jr.** They therefore rented the McGehee-Beall house to Alney's brother, John Jones and his wife, Jency Jones for several years. The Jones' had five children, three daughters and two sons, Sara, Sue, Dan, Raiford and another daughter who died as a child. They lived in the McGehee-Beall house for several years. Upon the death of Janie Lee McGehee Jones, her two children divided up the land, with Robbie Jones Yaun getting the house and the land upon which it was built. Alney Jones, Jr. received more land than Robbie to compensate for the value of the house.

### **The Fifth "Owner"**

In 1972, Janie Lee McGehee Jones and son Alney Webster Jones, Jr. "sold" to **Robbie Adair Jones Yaun** 46 acres with the house for the sum of \$10.00. Robie Yaun was the mother of seven children - Robin, Jesse, Charles, Janie, Lucy, John and Ben Yaun. Long before her death, after retiring from a job as a social worker for the state of Louisiana, and moving to "the Farm", Robbie decided to have all of the furnishings in the house appraised. After an annual family reunion, when all of her children could be present, (although two of her sons, Jesse and Charles, were at that time deceased), Robbie decided to have all of the children sit in the parlor and go down the list of the inventory of the furnishings in the house and decide who would get what when she passed away. Most importantly, it would be decided who would get the house. It soon was clear that several people wanted the same things, so to keep it "fair", it was decided that we would draw names of all the people who wanted the same items. The drawn name would get the item in question. First up, and most

important was the house itself and certain items that were thought to be original to the house. A hat was held above the head of Robbie Yaun for the lucky winner to be drawn.

### **The Sixth "Owner"**

And the winner of the lucky drawing for the house was..... **Robin Adair Yaun Schexnayder Elliott !!!!!**

Once again, the house was won by drawing a name from a hat! **Robin** was born December 10, 1947, almost 100 years after **Jane Ophelia "Janie" McGehee** (first drawing winner) was born on December 12, 1848)!!!!

Robin is the current owner/occupant of the McGehee-Beall House. Robin Elliott has three sons, Jeffrey Michael Schexnayder, David Allen Schexnayder and Zachary Steele Elliott.

**The next owner of the McGehee-Beall house is yet to be determined!!**

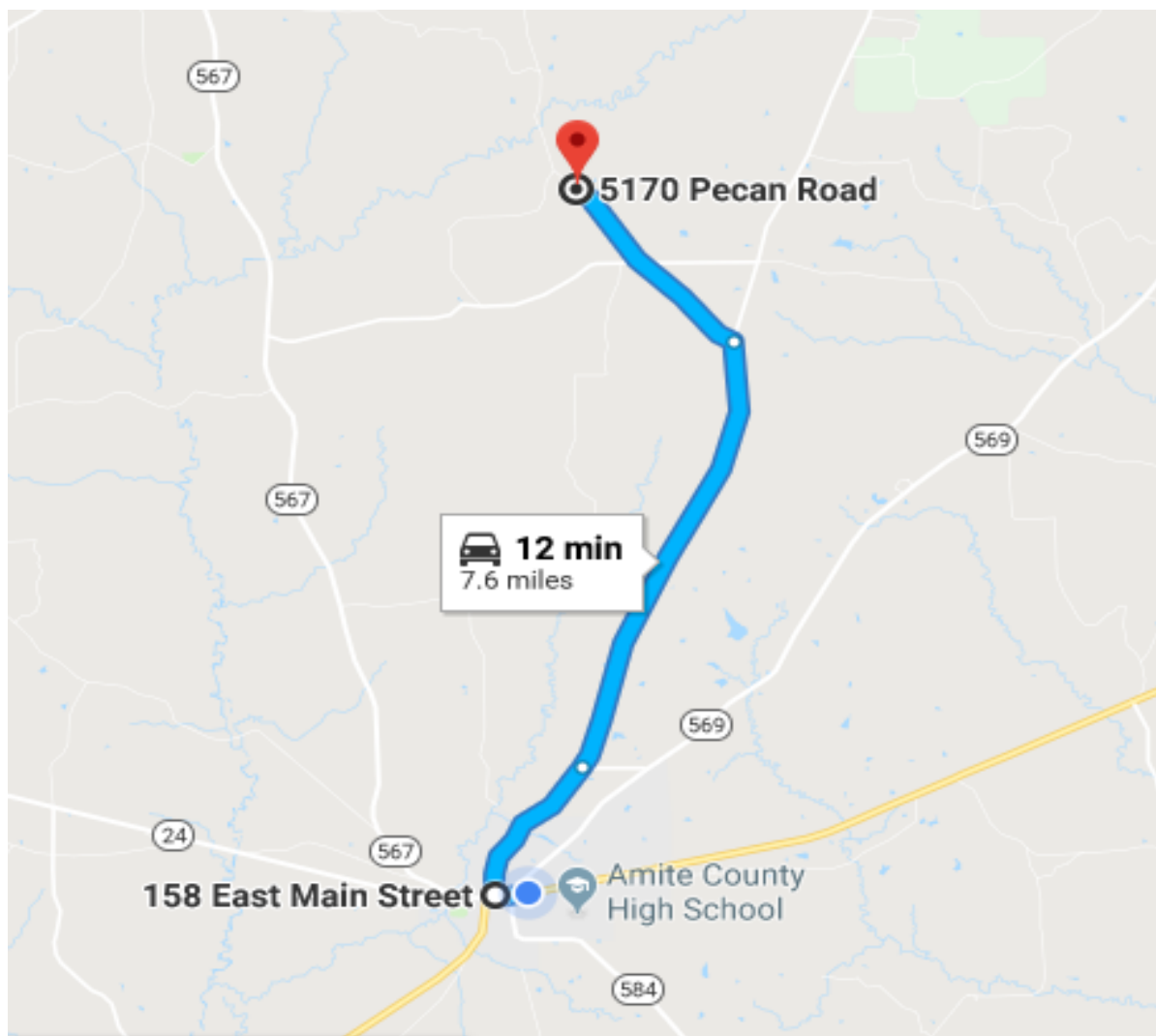
## **DIRECTIONS TO MCGEHEE-BEALL HOUSE**

From the east on Main Street, Liberty, MS

- 1) Take a right at the Bargain Furniture Store and head north on Meadville Road.
- 2) Go approximately 4 miles up Meadville Road to Parson Hill Church which will be on the left
- 3) Take a left at Parson Hill Church - this is Pecan Road
- 4) Go approximately 1.9 miles to 5170 Pecan Road which will be on the right immediately after the volunteer fire department

From the west on Main Street, Liberty, MS

- 1) Take a left at Bargain Furniture Store and head north on Meadville Road
- 2) Follow steps 2-4 listed above
