BITS AND PIECES OF AMITE COUNTY HISTORY

Recently, I had occasion to look back through some old books, magazines, and catalogs that my wife and I "rescued" from the garbage heap when my wife's grandfather's house was being cleaned out after may years of sitting idle. I found some materials of considerable age that contain items pertaining to Amite County. These will be reproduced or included here in the best manner possible for each given item.

Acts, Resolution, and Memorials Passed by the Mississippi Legislature 1877 Session

The first item is the Secretary of State certification of the correctness and completeness of the books as regarded the Legislature's actions. (Scan in jpg format.)

OFFICE OF SECRETARY OF STATE, JACKSON, MISS., April 10, 1877.

This certifies that the foregoing printed Acts, Resolutions, and Memorials, passed at the regular session of the Legislature of the State of Mississippi, held in the city of Jackson, in the months of January and February, 1877, are true and correct copies from the originals on file in this office.

Given under my hand and the Great Seal of the State of Mississippi hereunto affixed, the day and year first above mentioned. JAMES HILL, Scoretary of State.

I find it amazing that in 1877 the digest of the laws could be collected, proofed, and finalized for printing in 41 days after the session ended.

Changing the scheduled terms of session for the Chancery Court:

CHAPTER XXVII.

AN ACT to change the time and number of days for holding the Chancery Court in the counties of Amite and Franklin. Section 1. *Be it enacted by the Legislature of the State of Mississippi*, That the Chancery Court shall be holden in the County of Franklin on the second Monday in May and November, and continue six days if business so long requires.

Sec. 2. *Be it further enacted*, That the Chancery Court shall be holden in the county of Amite on the third Monday of May and Novem-ber, and continuo twelve days, if business so long require.

Sec. 3. *Be it further enacted*, That all pro-cess or publications returnable in the Chancery Court of Amite county, on the fourth Monday of May next, shall be deemed and taken to be the third Monday of said month.

Sec. 4. *Be it further enacted*, That this Act take effect and be in force from and after its passage. Approved February 1st, 1877.

This was scanned into a jpg file, run through an OCR program, then corrected for errors. The type and relative size of the font used approximates that of the original.

Creating a corporation in Amite County:

Due to the length of this act, it will be summarized here. Chapter CLXXXVII

AN ACT to incorporate the Amite County Manufacturing Company

Section 1—Identifies the initial stockholders and states the intent to form a corporation known as the "Amite County Manufacturing Company." The stockholders were identified as D.N. Butler, A.J. Roberts, C.H. Fritts, J.R. Sample, J.D. Roberts, and their associates, "together with those who may hereafter become stockholders…"

Section 2—Sets the initial stock value at \$50,000 and allows for increases after incorporation.

Section 3—Identifies the type of officers that will run the corporation, the terms of office, and the process by with power of attorney will exercised.

Section 4—Describes how stock purchase in the corporation is to be paid for.

Section 5—Exceptions to paying for stock at once.

Section 6—Describes the liability of the stockholders.

Section 7—Sets the life of the charter of incorporation at fifty years.

Approved, January 26th, 1877.

Apparently, the forming of corporations was eventually made a function of the Secretary of State, relieving the Legislature of having to act on each new incorporation.

HISTORICAL MEMORANDA.

The Grand Lodge of Mississippi was organized in the city of Natchez, on the 27th day of July, 1818, by a convention consisting of Masters, Wardens and Past Masters of Harmony Lodge, No. 33, holding under the Grand Lodge of Kentucky, Andrew Jackson Lodge, No. 15, and Washington Lodge, No. 17, holding under the Grand Lodge of Tennessee.

LIBERTY, No. 37-LIBERTY, AMITE COUNTY. (1837.)

Dispensation granted, ---, 1837; chartered, January 3, 1838.

I will not be able to accept/use just anything submitted. If information is sent by e-mail, it must be in the body of the message, in a *MS Word* document, or in a PDF document. If images of documents are sent they must be in JPG format so that I can attempt to convert them to text via an optical character reading application. If information is sent by postal mail, it should be in typewritten text, not handwritten, and should be a copy that doesn't have to be returned. Since about half our members receive the newsletter by print copy and the copying process will not adequately display photos, I cannot illustrate text write-ups. If photos are sent, do so only by electronic files in JPG format but don't assume the photos will appear in the newsletter. Photos sent in this manner may sometimes be put on the society's Facebook group page if they are likely to have wide appeal. I realize these criteria may prevent the sharing of some information; however, I must place some limits on the amount of time I devote to the newsletter each month since I have other projects including another monthly newsletter that I work on periodically.
