BITS AND PIECES OF AMITE COUNTY HISTORY

This month's offering comes from Allen Terrell who jumped into the fray when I became ill and pulled together some history/genealogy concerning the War of 1812. For those wishing to delve deeper than the information presented here, Allen recommends visiting the web pages listed near the end which allows the discovery of more information.

Colonel <u>Claiborne's Regiment of Mississippi Militia, Sept. 6, 1812 to February 13, 1813</u>.

The 1st Detachment of Mississippi Militia in service to the United States, known as "the detachment of Mississippi Militia in the service of the United States". under the command of Colonel Militia Ferdinand L. Claiborne. Baton Rouge, Louisiana. Total- about 900 men.^[4]

Colonel Claiborne's Regiment of Mississippi Militia^[5]

1st Regiment, Amite County, one company.

2nd Regiment, Wilkinson County, one company.

3rd Regiment, Adams County, three companies, including volunteer companies of Captains Becket and Painboeuff.
