### AMITE COUNTY HISTORICAL AND GENEALOGICAL SOCIETY

Minutes of January 9, 2009 meeting **DRAFT** 

Vice President Greg Barron called the meeting to order at 10:04 am in the meeting room of the Liberty library. He reported that President Oma Gordon would be absent due to the illness of her husband. There were 16 attendees. VP Barron asked Bro. Walt Gaston to open the meeting with prayer.

<u>President Report</u>: There was no report due to the absence of Pres. Gordon.

<u>VP Report</u>: VP Barron gave a brief report in which he:

- recapped the Open House event on December 6 and reported that based on the count made by a reporter from the Magnolia Gazette, over 250 persons attended;
- reported that ample funds were now available for paying the piper's attendance for the Bicentennial;
- reported that about 55 of the bronze doubloons are left for sale;
- listed the calendar dates for the quarterly meetings and the activities planned for those dates which include

and other historic buildings at Woodville (postponed from 2008 because of Hurricane Gustav damage)

>>December 5, 2009 - Annual Open House

<u>Secretary Report</u>: Secy. Wayne Anderson reported that one correction to the draft minutes of November 8, 2008 needed to be made – Bethel Presbyterian Church should be Bethany Presbyterian Church.

<u>Treasurer Report</u>: Treasurer Gay Blalock was absent but had left a printed report to be given. The bank balance as of the date of the meeting was \$5731.41.

VP Barron asked if everyone had read the minutes of the November 8 meeting and whether there were changes to be made in addition to the correction reported by Secy. Anderson. Nelson Dawson made a motion to approve the minutes as corrected; Glen Huff and Bill Rimes both seconded. The minutes were approved by vote of the attendees. The treasurer's report was approved in a like manner.

<u>Committee Reports</u>: Mrs. Vera Prestridge reported the following:

Open House – Mrs. Prestridge thanked all who helped with the open house and reported that 232 individuals formally signed in as attending and that \$310 was received from new members with an additional \$35 in donations. She has sent thank-you notes to the nonmember principals who helped with the event including Jonah Ford who owns the Felder-Richmond house and Jimmy Honea who lives on the property as caretaker. She reported that Glen Huff had sent a thank-you letter that was printed in the Southern Herald newspaper and thanked him for that gesture.

- Little Red Schoolhouse Mrs. Prestridge welcomed Bro. Walt Gaston to the society and to the LRSH Committee. She reported that the LRSH will be open for visiting on a walk-in basis on all three days of the main Bicentennial observance (April 30 through May 2, 2009).
- Natchez District Marker -- She reported that although the MDOT has obtained the pole for reinstalling the marker, it has not yet been erected.

Old business: None.

New business: Glen Huff reported that he had received a call from member Roger Barnes in California stating that the newly edited version of the Longmeyer history is available. Mrs. Vera Prestridge reported that the protective bars for the first floor windows of the LRSH are currently being refinished but suggested that the society should urge the reinstallation of the bars before the Bicentennial. James Allen Causey reported that the new town map of Liberty that was to be used for tours during the Bicentennial is fraught with errors and may require either a reprint or on errata sheet to be made accurate. Also, he reported that some sites may not be available for visitation due to land owner prohibition of access.

Other business: Glen Huff thanked Mrs. Vera Prestridge for her willingness to open the LRSH on Christmas Eve for an unexpected visit.

Hearing no additional business, VP Barron adjourned the meeting at 10:53 am. Nelson Dawson offered the closing prayer.
